Information Letter on the EUDR Deforestation Regulation (EU) 2023/1115

Subject: Current status of implementation

Dear Costumers,

the European Deforestation Regulation (EUDR) introduces new requirements for the traceability and sustainability of certain raw materials - including **natural rubber**, which is used in some of our products.

We would like to provide you with a transparent update on the current status of our implementation:

Affected materials

After careful review, we can confirm that the following materials in our product range contain natural rubber and are therefore affected by the EUDR:

- Elaqprem Basic (EPDM / NBR / CR)
- Elaqprem Standard (EPDM / NBR / CR)
- Elaqprem EPDM E215 / Elaqprem EPDM E220
- Elaqprem SBR
- Elaqprem LBM (EPDM light, NBR light, CR light, SBR light)
- Elaqprem Para
- Elaqprem wear protection
- Elaqprem Butyl
- Elaqprem Mats (fine rib / wide rib / ribbed mat / studded mat / electrical insulation mat, hammer finish mat))
- Other Mats: Cobra and Ring mat
- Conveyor belt qualities
- Tesnit qualities
- Rubber-steel gaskets NR

Status of supplier confirmations

We have already received the required confirmations of EUDR compliance from the majority of our suppliers. These include:

- Proof of raw material origin
- Confirmations of deforestation-free sourcing
- Traceability documentation

Some responses are still pending. We are in close contact with the respective suppliers to obtain the complete documentation as soon as possible.

Our own implementation – current status

At present, implementation of the EUDR has not yet been fully completed in our company. We are working intensively to meet all requirements and establish the necessary processes. This includes in particular:

- o Establishing and maintaining traceability documentation
- o Coordination with suppliers and upstream suppliers
- o Adaptation of internal processes and systems

Regulatory developments

The European Commission has submitted an official proposal to postpone the EUDR:

- For medium-sized and large companies: Application from 30 December 2026
- For micro and small companies: an additional deadline until June 30, 2027

In addition, the European Commission is currently reviewing further simplifications and adjustments to the EUDR in order to make its implementation more practical.

As soon as concrete decisions have been made in this regard, we will evaluate them and take them into account accordingly.

As soon as new information or relevant developments regarding the EUDR become available, we will inform you without delay.
